Technology Use Policy

Before a member is allowed to use club technology equipment or his/her own personal device, policy needs to be read and signed by parent.

Club devices and personally owned devices are permitted for use during approved club times for club purposes and in approved locations only. The club expressly prohibits the use of club devices or personally owned devices in locker rooms, restrooms, and other areas where there is an expectation of privacy.

Members may NOT use any technology to harass, threaten, demean, humiliate, intimidate, embarrass, or annoy their peers or others in their community. Any inappropriate use of a club or personally owned device, as determined by club staff, can lead to disciplinary action including but not limited to confiscating of the device, immediate suspension of the club, termination of membership or other disciplinary actions determined to be appropriate to the clubs existing disciplinary policies including, if applicable, referral to local law enforcement.

Boys and Girls Club of Lawrence reserves the right to monitor, inspect, copy, and review any personally owned device that is brought to the club. Parents/guardian will be notified before such any inspection takes place and may be present, at their choice, during the inspection. Parents/guardians may refuse to allow such inspections. If so, the member may be barred from bringing personally owned devices to the club in the future.

Members are responsible for keeping devices with it at all time. Staff are not responsible for the security and condition of the member's personal device. Furthermore, the club is not liable for the loss, damage, misuse, or theft of any personally owned device brought to the club.

Any inappropriate or unauthorized use of a club or personally owned device, as determined by staff, can lead to disciplinary action including but not limited to confiscation of the device, immediate suspension from the club, termination of membership, or other disciplinary action. Inappropriate communication includes but is not limited to the following:

Obscene, profane, lewd, vulgar, rude, threatening, Disrespectful language or images typed, posted, or spoken by members Information that could cause damage to an individual or the Club.

Personal attacks, Harassment or stalking of others

Knowingly or recklessly posting false information about a person or the club.

Members may not utilize any technology to harass, threaten, demean, humiliate, intimidate, embarrass, or annoy their peers or others in the Club. This behavior is cyberbullying, which is defined as bullying that takes place using emerging technologies and devices. Any cyberbullying that is determined to disrupt the safety and/or well-being of the club, club members, club staff or community is subject to disciplinary action.

Examples of cyberbullying include, but are not limited to:

Harassing, threatening, or hurtful text messages, emails, or comments on social media.

Rumors sent by text, email, or posted on social media.

Embarrassing pictures, videos, websites, or fake profiles.

Members are NOT allowed to use our clubs network unless authorized by a staff.

Minor Participant Waiver, Release, Indemnification of All Claims & Covenant Not to Sue

**PLEASE READ CAREFULLY, THIS DOCUMENT AFFECTS YOUR LEGAL RIGHTS AND IS LEGALLY BINDING, BY
THE SIGNING AGREEMENT YOU ARE RELEASING THE BOYS & GIRLS CLUB OF LAWRENCE FROM ALL
LIABILITY AND FOREVER GIVING UP ANY CLAIMS THEREFOR**

Assumption of Risk

I, in my legal capacity as parent/guardian of the minor named below ("minor"), acknowledge and agree that any use of the Boys & Girls Club of Lawrence facilities, services, equipment and premises ("Facilities") and any participation in the Boys & Girls Club of Lawrence programs and activities ("Programs") comes with inherent risk including, but not limited to: (1) moderate and severe personal injury, (2) property damage, (3) disability, (4) death, and (5) sickness or disease. I voluntarily, for myself and Minor, accept and assume full responsibility for these risks as well as any and all other risks of the use of Facilities and participation in Programs. I agree that I have full knowledge of the nature and extent of all such risks and am not relying on all such risks being described in this document.

Waiver, Release, Indemnification & Covenant Not to Sue

In consideration of Minor's use of Facilities and participation in Programs I, in my legal capacity as parent/guardian of Minor, agree on behalf of myself and Minor that Boys & Girls Club of Lawrence, its officers, directors, agents, employees, volunteers, insurers and representatives ("Releasees") will not be liable for any personal injury, property damage, disability, death, sickness or disease incurred by Minor, however occurring including, but not limited to, the negligence of Releasees. I understand that Minor and I will be solely responsible for any loss of damage, including personal injury, property damage, disability, death, sickness, or disease sustained from the use of Facilities and participation in programs.

I further agree, in my legal capacity as parent/guardian of Minor, on behalf of Minor, myself and any and all legal successors and proxies, to release and HEREBY DO RELEASE, WAIVE AND COVENANT NOT TO SUE Releasees from any cause of action, claims, suits, liabilities or demands of any nature whatsoever including, but in no way limited to, the claims of negligence, which Minor, myself, and any and all legal successors and proxies may have, now or in the future, against releasees on account of personal injury, property damage, disability, death sickness, disease or accident of any kind, arising out of or in any way related to the use of Facilities or participation in Programs, whether that participation is supervised or unsupervised, however the injury or damage occurs, including, but not limited to, the negligence of Releasees.

In further consideration of the use of Facilities and participation in Programs, I, in my legal capacity as parent/guardian of Minor, agree on behalf of myself and Minor to INDEMNIFY AND HOLD HARMLESS Releasees from any and all causes of action, claims, demands, losses, suits, liability or cost of any nature whatsoever, including claims of negligence, arising out of or in any way relate to the use of Facilities and participation in Programs.
